- I am experiencing hardship, and are one of the following: pensioner / health card holder / single parent / unemployed / student / legal carer or in special circumstances of hardship requiring food relief and I therefore seek approval by Foodbarn.

**If my circumstances change I will advise of such changes.**

I (name)..... agree to meet and abide by the requirements and requests of entry to Foodbarn or property thereof, as per conditions listed hereon or displayed on site or advised from time to time by New Life Foodbarn personnel. **Handling fees** - I understand handling fees are required for various items and services and respect the fact that they may change from time to time due to costs incurred. I acknowledge these handling fees. Some items are due to the generosity and sponsorship of companies, suppliers, manufacturers, charities and their price DOES NOT represent a selling price but the fee to help recover some costs of the charity involved in New Life Community Care operations and acquisition of items. Some items may be past the best before date, have damaged packaging, are end of line runs, etc. and I am aware that NO items may be exchanged, SOLD or returned for credit to stores, suppliers, or manufacturers other than New Life Foodbarn. I understand and accept that some fruit, vegetables, bread and/or other items may be free or a handling fee required, but I understand and accept that my selection is my responsibility and choice and no returns or exchanges except on that day of trading if the product exchange is available. I will NOT ON-SELL ITEMS and will only take and access the limits displayed and understand if any of the conditions herein or displayed on site are not adhered to or any directions given by Foodbarn personnel are not adhered to, the cancelling of my entry will be immediate. I understand that New Life Foodbarn is a community based service to supply relief supplies and is, and has, a not for profit goal in its running. This agreement is for the months until review in 2019 subject to Foodbarn still operating, with myself not being in breach of the conditions, or my situation changes. PLEASE NOTE- Only those who have a numbered card or this form will be able to access food outside or inside. You will have to show your cards when requested at the entrances and may have to sign in each time you arrive at the register point, otherwise no access to the food area will be allowed.
